Teddy Bekele

Chief Technology Officer | Land O' Lakes

Orbie Leadership Award: Moving from digital application to digital transformation



Teddy Bekele started his technology journey by tinkering with any new device that came his way.

As a child, Bekele set up his father's first computer and secretly loaded video games onto it to play when he had a chance. In college, he set up his dorm's first network, so the computers had instant messaging capabilities.

"The area that I've always enjoyed is the application of technology," said Bekele, the Leadership Award winner in the 2022 Minnesota CIO of the Year® ORBIE® Awards program, which honors excellence in technology leadership. "It is using an emerging technology and applying it to the real world to make a real impact."

Today, Bekele is leading the digital transformation at Arden Hills-based Land O'Lakes as senior vice president and chief technology officer of the third-largest member-owned agribusiness cooperative in the U.S. He and his team are evaluating and implementing disruptive technologies across the company's three business segments: dairy foods, feed and crop inputs. Their work includes advanced analytics, artificial intelligence, robotics and blockchain.

Bekele sat down with the Minneapolis/St. Paul Business Journal to talk about the future of technology leadership. The interview has been edited and condensed for length and clarity.

Where is Land O'Lakes today in its digital transformation process, and what are the next steps?

Bekele: I would say we've been dabbling with digital for eight years, but we've been in the transformation the last two years.

The real shift happens when the technology is at the core of the business model. As an example of what we're doing in our crop business, we're offering essentially recipes to farmers where we say to them, "If you follow this recipe, we know it will work because we've tested it in many different plots around the country and environments and soil types and everything else. Along with that recipe, you have to

use this technology because it is going to help you monitor where you are and help us monitor where you are in that journey. If you follow all the steps and you use the technology platform, you will get an outcome that's higher than your previous outcome. And we guarantee that; if we don't meet that outcome, we'll actually reimburse you for it."

That's the model we're shifting to, where the technology is at the core of selling a business platform. That is when transformation starts to happen because everything else up to this point is optimization.

Where is the agriculture industry in terms of technology transformation?


Bekele: There are some areas where we are well behind other industries. For example, a lot of products that are sold in the ag market are not barcoded, so you have no idea where certain bags of seed or jugs of nutrients are. It's crazy because the whole industry doesn't barcode; it's not just one organization, and this is technology that's existed since the late '70s.

But then, on the other hand, agriculture is well ahead of some other industries. They are using remote sensing, satellites and drones to monitor what's happening in a given field and using driverless vehicles. Even in the automotive industry, there are a couple of cars that can do it, and we're trying to figure out how to make it all work. But tractors pretty much drive themselves, and they have been for a couple of years now.

That's part of our job. In the areas we are behind, how do we make sure we can somewhat catch up to where everybody else is and then how do we continue to push the envelope on things that are forward-looking? It's exciting.

What are the biggest challenges facing CTOs and CIOs today?

Bekele: It's the same challenge our business leaders have in the organization: You have to run a business where we are today, and then you have to



It's not so simple because the business you're in is profitable today. It's very successful, and now you're saying, "Hey, at some point, we're going to be obsolete, and we should be doing this thing to make sure that we stay relevant, that we stay ahead of the game."

The other piece that's a huge challenge is attracting talent who wants to be there and cares about the organization. You have to give purpose to your team and make sure that they're not just there for the sake of technology and that they're applying the technology for a greater purpose.

Speaking of talent, what advice do you have for the next generation of technology leaders?

Bekele: It's the same advice that I was given: understand the foundation. Go do some software development. Go build the mobile app. Go spend some time in the guts of how all this even newer technology works. In the early part of your career, that's when you have the opportunity to try many different things.

Be curious. Learn what's out there. Understand it. Play around with it, even if it's on your own time. Have an eye on the future, but enjoy what you're doing today and be really good at that.




SUCCESS STORYAs I got on board, the two




